

# COOKIES POLICY



In compliance with Article 22 of Spanish Law 34/2002 of July 11, on Information Society Services and Electronic Commerce (LSSI), and in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 (General Data Protection Regulation, GDPR), as well as Organic Law 3/2018 of December 5 on the Protection of Personal Data and Guarantee of Digital Rights (LOPDGDD), the website makes available to users its Cookies Collection and Processing Policy.

### What Are Cookies

A cookie is a file that is downloaded to your device when you access certain websites. Cookies allow a website to, among other things, store and retrieve information about your browsing habits and — depending on the information they contain and how you use your device — they may be used to identify you.

### Cookies Used on the Website

The cookies used by the website <https://www.aindeep.com/> are classified as follows:

- **According to the entity that manages them:**

First-party cookies: These are sent and managed directly by Aindeep Technology Solutions.

- **According to their purpose:**

Technical cookies: These enable registered users to navigate the website, access restricted areas, and use various features, such as the comment system or the search function.

Customization cookies: These allow users to access the service with certain general predefined characteristics based on user-defined criteria, such as language preferences or the type of browser used to connect to the website.

- **According to their duration:**

Session cookies: These are designed to collect and store data while the user is browsing the website. They are deleted once the session ends.

Persistent cookies: These store data on the user's device for a defined period determined by the cookie controller, and the data can be accessed and processed during that time.

### List of Cookies Used

This Website may install the following types of cookies:

- Technical Cookies
- wp-settings-{user\_id}: A technical cookie used to preserve user settings in wp-admin. This is a persistent cookie with a duration of 1 year.
- hasConsent: A technical cookie that stores the user's consent. This is a persistent cookie with a duration of 1 year.

### Acceptance or Rejection of Cookie Installation

The Website displays a cookie banner accessible from every page, providing essential information about data processing. The banner allows users to:

- Accept the installation of cookies.
- Reject the installation of cookies or withdraw previously given consent.
- Access additional information about what cookies are, review the Cookie Policy, and manage their cookie preferences at any time, including accepting or rejecting cookies.

### Deletion of Cookies

Aindeep Technology Solutions displays information about its Cookies Policy through a cookie banner accessible on all pages of the Website.

The cookie banner provides essential information regarding data processing and allows the user to take the following actions:

- Accept the installation of cookies.
- Reject the installation of cookies or withdraw previously granted consent.
- Access additional information about what cookies are, review the Cookies Policy, and modify cookie settings at any time to accept or reject them.

### Acceptance or Rejection of Cookie Installation

You can accept, block, or delete the cookies installed on your device by configuring your browser settings. However, doing so may cause parts of the website to not function properly or affect the quality of your browsing experience.
